From Phil Jackson:

I am nominating Dustin for this Core Award for his ability to build lasting, mutually beneficial partnerships. His efforts and the rationale for this nomination are best captured in the following note received directly from the member office:

"Dustin Ilko takes professional service to the highest level. He is always on top of everything. Goes the extra mile. Very responsive. Stays in touch. Offers very good suggestions. A current case will serve as an example:

Lincoln's VUL One policy offers a Premium Reserve Rider (a/k/a PRR) which in certain situations allows policy holders to withdraw substantial amounts from the policy values without reducing the guaranteed death benefit. Those funds can be used to fully fund new coverage with any carrier. Lincoln's inforce policy illustration system is bizarre and cannot properly provide illustrations reflecting the exercise of the rider. We have been working on this case since early this year. Dustin set up a "zoom" meeting with the folks at Lincoln. He devised an Excel spreadsheet to adjust the Lincoln numbers (one error is that Lincoln shows an increasing guaranteed death benefit). Because we ran into insurability issues with the two clients, Dustin had to keep running illustrations from multiple carriers at varying rate classes. Never once did he complain about all of the work. Amazing. I could go on....

Thanks to Dustin (and to Chris for leaning on Lincoln) I was able to hit "Send" on what I hope will be the final proposal. Using the Lincoln PRR amount we hope to place a \$280,000 target sale this month. I honestly don't think I could have reached this point – whether we get the sale or not – without Dustin."
